WHIP PENALTY

To be used as a guide only with all circumstances of the breach to be considered.

4 th	Riding Fee + Prizemoney (Max) + 1 Meeting
5 th	Riding Fee + Prizemoney (Max) + 2 Meetings

Prior to 100 Metres Successive strokes AR137A(5)(a)(i)

- As a deterrent breaches in feature races (\$60,000 +) may attract a heavier penalty.
- A rider’s record refreshes each 400 rides and/or 12 calendar months.
- Penalties for other breaches of the whip rules shall not be inconsistent with guidelines.
- A rider’s breach of the whip rules prior to the 26th September 2009 may be taken into account when assessing penalty
