## SECTION 2: Conditions of Registration

I acknowledge that the issue of any permit to act as a Bookmaker in the area under the jurisdiction of Thoroughbred Racing NT will be dependent on my agreement to abide by the following conditions.

1. That I agree to be bound by the Rules of Racing and Betting in force from time to time during the currency of such registration or any renewal thereof, and also such Rules, Regulations, conditions and directions as may from time to time be made or given by the Committee, Stewards or Officials of the Club.
2. That I agree to record correctly every bet made (whether as a layer or a bettor back, except in the case of horses which I own) immediately after the bet is made in the ledger provided by the Racing Commission, and to provide the original copy thereof whenever required by the Stewards or other authorised Officials of the Club.
3. That I will accept bets only on such meetings as I am authorised to bet on by the Club, and I will accept bets only from such stand as is allocated to me by the Club from time to time.
4. That I will employ only clerks who hold the necessary permit issued by the NT Racing Commission, and registered by Thoroughbred Racing NT.
5. That I will accept only such forms of bet ie. win, each way, place only, quinella, double, all-up, concession, as I am authorised to accept by the Club.
6. That if I am convicted of an offence under the provisions of the Northern Territory Racing and Betting Act (1983) or Regulations, or otherwise found by the Committee to have engaged in illegal off course activities, the Committee may cancel or suspend my permit without notice to me.
7. That I agree not to make any public statement or comment concerning any matter currently the subject of investigation or inquiry before the Stewards, Board, Committee or Appeals Body.

Thoroughbred Racing NT collects personal information about you when you apply for a licence pursuant to the Northern Territory Racing and Betting Act and the Rules of Racing. Thoroughbred Racing NT, as part of its licensing and disciplinary processes may disclose such information to third parties as part of the process of considering whether to grant or maintain your licence. You do not have to supply any information sought but failure to do so may result in your application for a licence being refused or withdrawn. By completing and submitting this form, you authorise Thoroughbred Racing NT to collect, use and disclose personal information about you for the purpose of the Racing and Betting Act and the Rules of Racing.
